LA City Council Resolution on EAD

Ådopted Friday December 15, 2000

WHEREAS, in 1990 the Los Angeles City Council established the City's Environmental Affairs Department, created the Environmental Affairs Commission to advise the new department, and confirmed appointment of the department's first-ever General Manager;

WHEREAS, by creating the Environmental Affairs Department, the City Council formed a department that provides expertise to the Council, Mayor, other City departments, and the public on a wide range of environmental matters to help ensure a sustainable, clean and healthful environment for all people of Los Angeles;

WHEREAS, the Environmental Affairs Department has worked to make Los Angeles a leader in the protection and enhancement of the urban environment by integrating and linking a clean and healthful environment with the need to promote equity among all people and to ensure a strong economy;

WHEREAS, in its 10-year existence, the Environmental Affairs Department has brought more than \$15 million in grant funds to the City for environmental programs such as the El Segundo Dunes Restoration project, the Quick Charge LA electric vehicle charging infrastructure program, and the Brownfields Showcase Community program;

WHEREAS, the Environmental Affairs Department has provided invaluable assistance to the City on environmental issues that resulted from events like the civil disturbance of 1992 and the Northridge earthquake of 1994; has supported the City's efforts to revitalize economically and

planting of more than 10,000 shade-producing and energy-saving trees in the City, the purchase and operation of more than 600 clean, pollution-reducing alternative-fuel and electric vehicles within the City's fleet, and in the Local Enforcement Agency conducting 6,000 inspections of landfills, transfer stations, waste vehicle collection yards, and other permitted facilities since 1992;

WHEREAS, the Environmental Affairs Department has effectively represented the City's interests on a wide range of policy issues at the local, regional, state and federal levels, including participating in the National Environmental Justice Advisory Committee, the Children's Health Protection Advisory Committee, the Clean Cities Program, the Cities for Climate Protection Campaign, the Los Angeles Urban Resources Partnership, and the National Pollution Prevention Roundtable;

WHEREAS, the Environmental Affairs Department has won numerous awards for its outstanding programs, including the Governor's Award for Environmental and Economic Leadership, the South Coast Air Quality Management District's Clean Air Award, Renew America's National Environmental Achievement Award, and the U.S. Environmental Protection Agency Outstanding Achievement Award for Environmental Protection Through Pollution Prevention.

Businesses Can Learn the ABC's of Environmental Compliance

Is your business overwhelmed with environmental requirements? With the help of the Environmental Business Assistance website, published by the City of Los Angeles Environmental Affairs Department, business owners can easily learn the ABC's of environmental compliance: http://www.lacity.org/EAD/eba/chartfrm.htm, by following steps A, B, and C:

Step A includes use of a chart listing 13 basic and important questions business owners should ask themselves if they keep hazardous substances on-site. Answers, permit information and agency links are provided.

Step B goes further. It includes use of a comprehensive listing of potential hazardous waste management permits. A business can use the table provided as a checklist to identify permits or requirements that might apply to them. Then, at their own pace or as the need arises, access an easy to-read companion guidance manual for further explanation.

Step C includes use of an on-line State directory. The directory narrows down permit requirements and resources for a particular business type, located anywhere in California. In the winter of 2000/2001, an updated and similar directory, written specifically for businesses in the City of Los Angeles, will come on-line. "The growing Environmental Business Assistance website reinforces the City's commitment to provide important information to the business community on environmental issues, and to make information more accessible," said EAD General Manager, Detrich B. Allen.

EAD RANKS AMONG TOP CITY AIDS WALK TEAMS

Congratulations are definitely in order for the Environmental Affairs Department's 2000 AIDS Walk Team, which ranked among the top City departmental teams. EAD's team had 21 registered walkers that raised \$2,067.50 for AIDS Project Los Angeles (APLA) and 16 other benefiting AIDS service organizations as part of the City of Los Angeles' annual campaign for AIDS Walk Los Angeles. Among the 38 City departments that participated in this year's campaign, Environmental Affairs was the third largest team in regard to number of walkers, and eighth in the amount of money raised. Recycle Your Christmas Trees!

After the holiday festivities are over, remember to recycle your holiday greenery and in particular, your Christmas tree! It is illegal to leave Christmas trees on the street because they are a fire hazard, but you can place them in your green recycle bins. Before placing trees in the bins, remove all

decorations, tinsel, and stands. Please note, flocked trees cannot be recycled. Trees may protrude up to one foot above the bin top; however, you may need to break them into smaller pieces in order to make them fit. The largest City team was the Library Department, which had 30 registered walkers. The City team that raised the most money was the Fire Department, which raised \$4,374.25. Considering the relatively small size of EAD in comparison to most other departments, EAD's consistent effort on behalf of APLA and others was remarkable and to be commended.


On a larger scale, the City of Los Angeles' combined team effort was outstanding again this year. The City's combined grand total was \$47,116, making the City of Los Angeles the third largest group fundraiser among the more than 800 corporate and community teams who participated this year, exceeded only by the teams from media in dustry giants Time Warner and Dreamworks Pictures (in that or der). The City is particularly pleased that it beat out the County of Los Angeles for third place and once again regained its title as the "Number One Governmental Team."

The City of Los Angeles' laudable effort helped to make the 16th Annual AIDS Walk Los Angeles consistently one of the largest AIDS fundraising events held in Southern California. This year, nearly 27,000 walkers joined the City on October 15 to raise \$3.1 million for APLA and the 16 other beneficiaries. The money raised will help to provide life-sustaining services for over 10,000 men, women, and children living with HIV and AIDS, and strengthens their important education and advocacy programs. EAD would like to thank everyone who gave so generously to our campaign effort this year. We couldn't consistently do so well without your continued support. We certainly hope we can count on you again in next year's campaign, because as long as there's a need, we're going to do our best.


