## **Construction Kick Off at Taylor Yard Park**

Bulldozers are now rolling on the construction of Los Angeles's newest park. Taylor Yard, in the Cypress Park area near downtown Los Angeles, is a joint project between the City of Los Angeles and California State Parks. The

forty-acre site includes soccer fields, tennis courts, baseball fields, basketball courts, hiking trails, children's play areas, and picnic and natural areas.

For the past year, State Parks and City Officials have worked with hundreds of community members to design the innovative new park. The plan that has emerged combines the need for sports fields with restoration of the Los Angeles River and hiking and bicycle trails. State Parks' Director Ruth Coleman explains "this community has pushed for something unique in its beauty and use, something

## **Air Quality Almanac**

The California Air Resources Board's Almanac of Emissions & Air Quality - 2005 Edition recently has been released to the public. The almanac was prepared and published by the staff of the Air Resources Board (ARB) Planning and Technical Support Division. This document gives the reader an excellent overview of the levels of air pollutants in different areas of our state, the sources of these pollutants, and the progress being made in reducing them. Air pollution is one of our state's most serious problems.

The almanac was prepared and published by the ARB staff to aid air quality professionals and the public in evaluating air quality in California. The ARB, as part of the California Environmental Protection Agency (CalEPA), is the State board responsible for achieving and maintaining healthful air quality in California. This responsibility is shared with local air districts and the United States Environmental Protection Agency (U.S. EPA).

This is the sixth edition of the almanac, which is updated annually as additional air quality and emission inventory data become available. Copies are only available online and can be downloaded at: http://www.arb.ca.gov/aqd/almanac/almanac05/almanac05.htm.

with multiple recreational uses and natural areas, something that will enhance their neighborhoods. We are proud of what they have done and delighted to begin building it."


Taylor Yard park emerged in the early 1990s through a community planning process. State Parks purchased the property in December 2001 and final planning began on the park. In August 2003 the City of Los Angeles and State Parks unveiled their agreement for developing Taylor Yard. Half the park is leased to the City for a sports park and State Parks is responsible for the natural and environmental park portion.



### The City's General Services Department Making **Environmental Sense**

The City of Los Angeles General Services Department (GSD) has made great strides toward protecting the quality of the air we breathe with its aggressive policies to purchase environmentally friendly vehicles. In addition to protecting the environment, this program has helped GSD with its bottom line finances. GSD has purchased and put into service 455 hybrid gas/electric vehicles for general fleet use. The integration of these vehicles into the fleet has decreased fossil fuel consumption by about 6 % in the 2003 fiscal year, leading to bottom line cost savings. In addition, GSD has developed

a proactive maintenance standard. It also offers tips for conserving fuel through its participation in the statewide program "Flex your Power at the Pump". The tips are simple actions that can be easily used with one's personal vehicle as well as City vehicles.







### **TransitPeople**

Have you ever packed up your family and taken the bus to the Zoo? Or taken the subway to Central Library? Have you ever thought that maybe using public transportation could be a part of the adventure?

Meet TransitPeople, an all-volunteer non-profit organization that takes schoolchildren and their teachers out on Fridays and weekends to museums and places of interest all over Los Angeles. The organization advocates the merits of public transportation, and familiarizes the young riders and their caretakers with Los Angeles' transit system. Trips enable the children to explore the City's cultural and science attractions, parks, and more. By taking excursions using the bus or train, group leaders empower the children to also take their families out to the same sites using the same mode of transit, and to assist teachers with incorporating museum visits into their curriculum.

The idea was conceived back in 1999 by Tim Adams, an educator and also a supporter of public transportation. With funding for field trips being cut, most schools were not

able to afford one field trip per year. Many of his students had few stimulating activities on the weekends. Adams organized Saturday field trips out to places that they had never visited, and they traveled in a way that enabled them to see more of the life within Los Angeles.

To date, TransitPeople has taken over 9,000 school-aged travelers all over Los Angeles, even heading south down to San Juan Capistrano, and also going as far north as Ventura. Volunteers stress safety, and supervise 15 to 20 children in a group. Due to increased demand, outinds now range from 12 to 18 trips per month. Private donations  $v_{asquez}$ cover the children's admission and transportation fees. ## City's Recycling Program Expands to Multi-Family Housing

The Department of Public Works Bureau of Sanitation is expanding the City's recycling program to reach hundreds of thousands of residents living in multi-family buildings such as apartments and condominium complexes. Phase One of the program, launched in early February, will reach 100,000 units of the City's 600,000 multi-family dwellings. Currently 21,000 units are participating in the program, with more units being added to the program as contractors add recycling routes. 

## The Kyoto Treaty

Last February, the Kyoto Protocol went into effect in which 140 nations signed a treaty obligating them to reduce emissions of greenhouse gases (GHG) by 2012. Adopted in December 1997 in Kyoto, Japan, the Protocol sets binding targets for developed countries that would reduce their emissions on average 5.2 % below their 1990 levels.

The key goals that the Protocol sets forth in reducing emissions are:

- § calling on all treaty nations--developed and developing--to take a number of steps to formulate national and regional programs to improve "local emission factors," activity data, models, and national inventories of greenhouse gas emissions and "sinks" that remove these gases from the atmosphere;
- § committing to formulate, publish, and update climate change mitigation and adaptation measures, and to cooperate in promotion and transfer of environmentally sound technologies and in scientific and technical research on the climate system;
- § emissions trading, with the proviso that a nation cannot entirely fulfill its responsibility to reduce domestic emissions by relying primarily on emissions trading or joint implementation to meet its targets. Joint implementation is project-based activity in which one country can receive emission reduction credits when it funds a project in another country where the emissions are actually reduced.

The United States is not currently a signatory to the Kyoto Protocol, but the City of Los Angeles has implemented a Climate Action Plan to reduce greenhouse gas emissions by 30% from 1990 levels by 2010.
